Our investment portfolio is the result of a thorough analysis, investing only in situations with quantifiable and limited downside and with asymmetric risk return profile, where upside potential exceeds significantly downside and stress test scenari. In the absence of compelling investment opportunities, we are able to hold cash patiently.

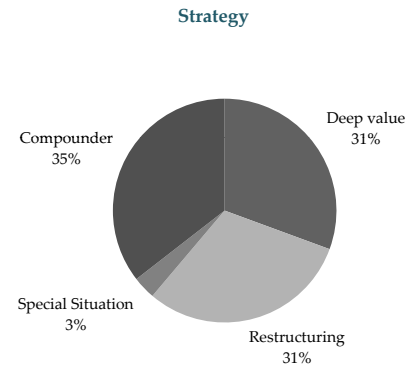
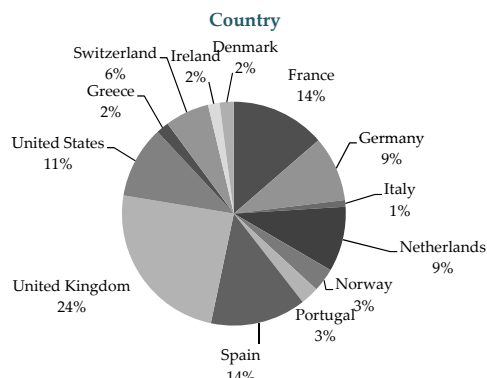
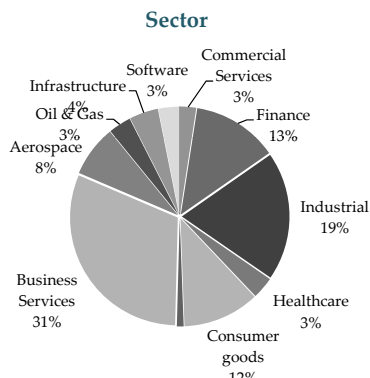
EQUAM Global Value has continued to outperform the major European indices and with an 8.7% ytd return beats the Eurostoxx by 13.8%.

In August we have made an initial investment in Sports Direct, the UK's largest sporting goods retailer. After reporting full year results that were below expectations (2.5% revenue growth and stable ebitda) the share price has fallen significantly. We bought SPD, which has a net cash position and is managed by its founder and main shareholder Mike Ashley, at just 6x earnings.

We have taken advantage of the sharp increase in the share price of some of our companies to adjust weights to target, selling shares in ING, Serco, Leoni and Tecnicas Reunidas.

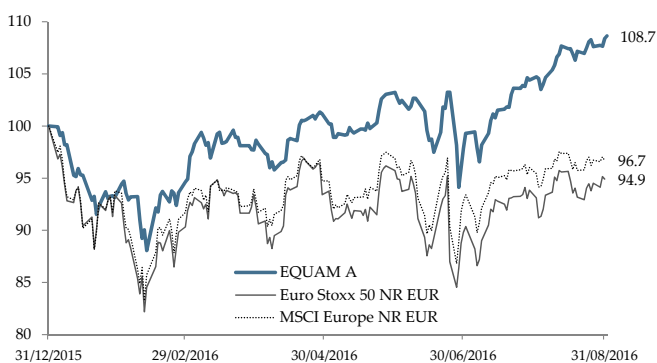
The companies in our portfolio keep reporting satisfactory results.
